STATEMENT OF FAITH

We, at Milpitas Christian School (MCS), believe we can personally know God through Jesus Christ. We worship one God – Father, Son, and Holy Spirit. We believe God loves us so much that He sent His Son, Jesus Christ, fully God and fully man, to pay for our sins. He makes possible a relationship with Him, and gives us eternal life through His death and resurrection. In order to be united with God we must accept by faith what God has done through Christ.

We agree that the Bible is God's Word, completely true, providing His direction and authority for our lives. The Bible shows us how to know Jesus Christ and become more like Him and desire to do His will. We learn to rely on Him and grow in our relationship with Him as the Holy Spirit acts in our lives.

This school is an outgrowth of this personal relationship with Jesus Christ. Our commitment as a school is to share this relationship and our lives with each other, with our students, and with our community, upholding each other in our spiritual growth and everyday struggles. Together we look forward to Christ's return.

4. We believe in the absolute necessity of regeneration by the Holy Spirit for salvation because of the exceeding sinfulness of human nature, and that men are justified on the single ground of faith in the shed blood of Christ, and that only by God's grace and through faith alone are we saved (John 3:16–19, 5:24; Romans 3:23, 5:8–9; Ephesians 2:8–10; Titus 3:5).
5. We believe in the resurrection of both the saved and the lost; that they are saved unto the resurrection of life, and that they are lost unto the resurrection of condemnation (John 5:28–29).
6. We believe in the spiritual unity of believers in our Lord Jesus Christ (Romans 8:9, 1 Corinthians 2:12–13, Galatians 3:26–28).
7. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly life (Romans 8:13–14; 1 Corinthians 3:16, 6:19–20; Ephesians 4:30, 5:18).


Welcome to the 2018/2019 school year. We are honored that you have entrusted us with the education, care and nurturing of your child(ren) for this school year.

This handbook outlines the financial responsibilities we share as parents and as school administrators. The Business Office staff is pleased to provide monthly billing statements through which you will be able to make one monthly payment covering tuition and other school expenses.

The commitment for the financial services MCS provides to your family is between parents and the staff in the Business Office. In doing so, we enable the school office staff and teachers to care for and educate your child(ren). We do not send any financial information through the classrooms, and we ask the same of you. Please do not burden your child(ren) with the responsibility of financial issues.

The Business Office hours are normally 8:00 AM - 4:30 PM. However, if you need to speak with us we will gladly make arrangements to meet with you before or after hours, as your schedule allows. Should you have any questions, please feel free to call (408) 945-6530.

Tuition

Preschool. Preschool tuition is billed monthly. When the preschool will be closed for a week, the tuition will be prorated. Should a student begin or leave the preschool after the first of the month, the tuition will be prorated in quarter-month increments.

TK-8. For grades TK-8, the tuition is an annual amount. It is not prorated for holidays or school breaks.

Payment Plans

Parents have the option to select various payment plans which complete payment of the entire annual tuition amount by the May due date for grades Kindergarten through 8th grade. Payment plan options are:

- 11 months July to May
- 10 months August to May
- 9 months September to May
- Annual Please refer to “Prepayment Discount” for details.

Methods of Payment

1. Electronic Fund Transfer (EFT) – This mode of payment can be used for any of the payment plans above (monthly or annual). A new EFT form must be signed every school year and every summer program. Indicate on the EFT form when you want payments debited from your account: 10th, 15th, or 20th of the month. If the date you have chosen for the EFT happens on a weekend or holiday, we will always request the transfer on the business day following the date you selected.

An EFT payment that comes back *Non-Sufficient-Funds (NSF)* may be presented for payment a second time, five to ten days later, and a \$25.00 service fee will apply. (For example: if a payment is presented for \$500.00 on the 10th and is NSF, it may be presented again on the 20th of the same month, and a \$25.00 NSF service fee will be charged to your statement.)

2. Credit Card – This mode of payment can only be used for annual tuition. Use your Visa, MasterCard or Discover to pay annual tuition in full **July 1st – July 15th** of each academic year.

If needed, exceptions to these two payment options will be made on an individual basis. Please come to the Business Office to make this request. A \$50 fee for using an alternative payment method will apply.

Prepayment Discount

A 2% prepayment discount will apply if:

1. A returning student is enrolled and paid the full annual tuition by July 15 of the academic year being enrolled.

2. A new student is enrolled and paid the full annual tuition by December 1st of the academic year being enrolled or within 30 days of initial enrollment;

Late Payments/Insufficient Funds/Returned Check

Tuition payments are subject to a \$25.00 late fee if not paid by the selected monthly date/insufficient funds/returned check. An additional fee of \$25.00 will be applied each month that tuition remains unpaid.

Security of Information

The security of the information you provide to us is a critical issue to MCS. We use an industry standard secure avenue to transmit the EFT information to our bank. There is a built-in procedural oversight to prevent unauthorized withdrawals from your bank or credit union. Please be assured that at no time does any person at MCS have the ability to see or access any portion of your banking balance information.

Statements

Each family will receive a monthly statement via mail or e-mail, as requested.

Mail

Statements will be mailed by the 6th of each month from the Business Office. Please keep your address current with the Business Office to ensure timely delivery.

E-Mail

Statements will be e-mailed from the Business Office by the 6th of each month. We have the capability to send an e-mail to two addresses. The statement is sent as a PDF file and can be viewed by using *Adobe Acrobat Reader*. Should you or the place that receives your email have a filter program, please make sure to designate tuition@milpitaschristian.org as a viable recipient. Please keep your e-mail addresses current with the Business Office and let us know if you are experiencing any problems.

Please put your family's account number on any correspondence with the Business Office. This number can be found at the top right of your monthly statement.

Family Discounts

Family discounts apply to tuition only and will be automatically deducted from the tuition amount due. Families with children in the elementary/middle school and preschool will receive the family discount rate on the elementary or middle school tuition, regardless of the preschool start date.

2018/2019 discount rates are as follows:

- 2 children: 4% per family, per year
- 3 children: 10% per family, per year
- 4 children: 22% per family, per year

Please Note: Family discounts are offered only to bona fide siblings living with the financially responsible parent or guardian. Any fraudulent use of MCS discount policies may result in a family's termination of your school relationship.

Christian Service/Pastoral Discount

Milpitas Christian School offers a discount to families whose parents serve as full-time paid employees of a church or Christian service organization. To receive this discount, written verification is required, full-time status must be maintained, and your account must remain current.

TK-8 Extended Care

TK-8 extended care is available from 7:00 AM to 6:30 PM and is based on a monthly contract signed at the beginning of each school year. Extended care charges for the elementary and middle school will appear on your monthly statement in one of three ways:

1. Morning and afternoon extended care contracts will be billed with the current month's tuition.
2. Hourly extended care contracts will be billed at the end of each month and are due with the next month's tuition.
3. Emergency drop-in extended care used within a month will be billed at the end of that month, and will be due with the next month's tuition.

Extended Care contracts are maintained in the Business Office, which gives our Extended Care staff more time to be with the children. Contract changes must be submitted to the Business Office on or before the 1st of the month in which the change is to take effect. (For example, if you want a contract change to begin in February, a contract change must be submitted on or before February 1st.) Contract changes submitted after the 1st of the month will be in effect the next month. One extended care contract change per year is free. Each subsequent change will incur a \$25.00 fee.

Lunch

Lunch service is available at Milpitas Christian School. For students TK-8th grade you will be able to log in to our providing company and select from their menu any lunch for you child. There are vegetarian options and you can order just a drink from this menu. Extra entrees are available to all students where we only had this option for middle school in the past. You will be required to pay for what you have ordered by credit card. This will require 2 day advance planning on the part of families.

Lunch is included in the tuition for full-time preschool students. Part-time preschool students staying through lunchtime will be provided with a meal and the family's account will be billed at the preschool lunch rate.

Band and Instrumental Music

Band and instrumental music lessons are contracted on a monthly basis and provided by MCS music staff. The band registration fee, required of all participants, will be charged to your MCS statement. Fees for music lessons will be charged to your monthly statement and are due with that statement.

Additional expenses may be added, for items such as music books, instruments, parts and repairs, t-shirts, etc. The music staff will notify you when these expenses may occur. Should you rent an instrument from the school, there will also be a fee.

Vocal Music

The Honor Choir is a select group of students who perform on behalf of the school and participate in musical festivals and/or competitions. Honor Choir is a class in the middle school schedule. No additional charges occur unless otherwise communicated by the choir director.

Sports

MCS encourages all students at the middle school level to participate in the sports programs. A fee of \$75.00 will be charged for each sport in which a student participates.

Learning Lab

Milpitas Christian School offers onsite student evaluations. We offer tutoring and assistance to help students be successful in their academic endeavors. Monthly tutoring contracts or per-session rates are decided at the time the need is assessed. They will be charged to the MCS account and will be included on monthly statements.

Financial Aid/Assistance

Milpitas Christian School sets aside funds to offer financial aid to those that are in need. Applications are accepted February through June for the upcoming school year. MCS uses an outside agency to assess a family's level of need. Families receiving financial aid must keep their account current in order to maintain the financial aid. Some of our families qualify for assistance in paying for preschool and extended care expenses through county and other outside agencies such as *PACE*, *Choices for Children* and *4C's*. We are happy to work with these organizations; however, it is still the responsibility of the parent(s) to insure that proper and timely payments are made to MCS on their child's behalf. Additional paperwork is required from these agencies. If an MCS family utilizes their services please contact Lisa Lewis to review your responsibilities and the potential for extra fees to be levied if proper procedures are not followed.

Withdrawal Policy

Families that withdraw a student from school with less than thirty days written notice will be charged \$500 or half of one month's tuition, whichever is less, for each child enrolled. Application and enrollment/re-enrollment fees are non-refundable.

Delinquent Accounts

Our programs and services outlined above require consistent payments. A \$25.00 fee will be assessed each month a tuition payment is late (e.g., if tuition has not been paid for two consecutive months, the late fees would be a total of \$50.00). A family whose account becomes more than thirty (30) days overdue may be withdrawn from the school until the account is current. The MCS Business Office staff works with families that are enrolled and whose account has become delinquent. Parents who communicate their particular situation may receive some grace. Should a family leave and their account is not paid in full within thirty (30) days, the balance may be turned over to collections and the parent's credit report will be noted.

Receipts

If your employer provides a pre-tax Section 125 reimbursement plan, we are happy to fill out and sign the appropriate forms for your reimbursement benefits whenever you need them. If you need a receipt for any payment made to MCS, the Business Office is happy to provide one.

Work-Off Hours

It is the policy of the Birchwood campus, for TK – 8th grade families, to require parent/sponsor/guardian participation. Twelve hours are required for one child and four additional hours for each sibling, with a maximum requirement of 20 hours per family per school year. The hours will be compiled with the help of our staff. Incomplete work-off hours are billed at the end of the school year at the rate of \$40.00 per hour of service not performed. The hours will be prorated if a family leaves prior to the end of the school year.

Work-Off Hour Reporting Coupons are available in the School Office and Business Office. Once the coupon is signed by the appropriate staff member, please turn in the white copy to the Business Office or place it in the School Office drop-box. Please retain the yellow copy until you receive your July statement, in case there is a discrepancy. Balance reports will be sent home two or three times a year, usually with your child's report card.

Fundraising Activities

The Head of School first approves all fundraising activities. We currently have one major fund raising event: RACE for Education. All monies given to this fundraising event are tax deductible.

Tax-Deductible Donations

MCS will issue a receipt for donation of \$250 or more.

Cash or Goods - Any donation of cash or goods to MCS is fully tax-deductible. It is the responsibility of the donor to estimate the value of goods being donated. At a certain level of value, an appraisal is required.

Services or Labor - Donations of services or labor are not usually tax-deductible.

Stock Donations - Donations of stock are a good way of giving to the school. If you donate stock to MCS, full value of the donation goes to our ministry. In addition, you do not pay the capital gains tax and you receive an income tax deduction for the full market value of the stock.

Corporate Matching Gifts – Many local corporations will match their employee's cash donations to the school. In the past, we have received matching gifts from *Adobe*, *Guidant*, *Lam Research* and others. Some companies will make donations for your time spent volunteering at the school. We have received such "volunteer funds" from *Intel*, *PG&E*, and *Lockheed-Martin*. Please consult your employer to take advantage of these opportunities to support Milpitas Christian School.
